2. The documents shall be given on deposition of cost of Tender document with the Sr. Cashier/ Cashier, Govindpur Area.
3. Tender must be submitted in two part system (other credentials in Envelope I and Rate part only in Envelope II) in the office of the Area Civil Engineer, Govindpur Area upto 3:30p.m. on **07.01.2010**. Part-I of the tender will be opened on same day at 4:00 p.m. onwards in presence of tenderer or their authorized representatives. However Part-II will be opened on the same day (of those tenderers only who qualify for opening of their rate as per eligibility criteria) / any other day with intimation to the qualified bidders.
4. The minimum eligibility criteria for consideration of work of the contract shall include the following :-
  - a) The intending tenderer must have its name as a prime contractor experience of having successfully completed similar nature of job during last 7(Seven) years ending last day or month previous to the one in which bid applications are invited (i.e. eligibility period) should be either of the following:-

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

OR

Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

OR

One similar completed works each costing not less than the amount equal to 80% of the estimated cost.
  - b) Average annual financial turn over of civil works during last three years ending 31st March of the previous financial year should be at least 30% of the estimated cost.
  - c) Similar works means :- Civil work
