Sealed tenders are invited on percentage/above/below basis from bonafide, experienced and resourceful contractors for the following work -

Eligibility Criteria.

1. The intending tenderers must have in its name, experience of having successfully completed similar works during last 7 years ending last day of month, previous to the one in which bid application are invited (i.e. eligibility period) should be either of the following
 - a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost
 - Or
 - b) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost
 - Or
 - c) One similar completed work costing not less than the amount equal to 80% of the estimated cost
2. Average annual financial turn over of civil works during last three years ending 31st March of the previous financial year (i.e during 2006-07 to 2008-09) should be at least 30% of the estimated cost.
3. Similar work means that the tenderer should have experience of structural steel works including sheeting.

TERMS & CONDITIONS

1. Conditional tenders will not be accepted.
2. Tenders are to be submitted separately in two sealed covers containing (i) Techno Commercial bid and (ii) Price bid. The techno-commercial bid should contain the proof of eligibility criteria as fixed above the earnest money and details of TIN & PAN No. The part-I will be opened on 07.01.2010 at 4.00 P.M. The part-II containing the price bid will be opened by the Committee only after acceptance of part-I.
3. Interested and eligible applicants can have the tender documents after depositing the cost of tender from the office of Dy.CE (C), KNTA from 04.01.2010 and 05.01.2010 during office hours only.

4. The experience given in the eligibility criteria should be in the name and style in which tender is filled. The experience of the partner if any, in name or firm/company will not be counted for the purpose.
5. The tender will be received on 07.01.2010 up to 3.30 P.M. in the office of Incharge KNTA and part-I will be opened at 4.00 P.M. on the same day in the office of Incharge, KNTA in presence of the intending tenderers or their authorized representatives.
6. The Management of BCCL reserves the right to reject any or all the tenders without assigning any reason whatsoever or to split up or distribute the work among the tenderers.
7. Tender will be finalized as per the guideline of CIL's manual for Civil Engg. Works. The manual will be available for reference with office of Dy.CE (C), KNTA during sale of the tender documents.
8. The tender documents will be issued to the prima-facie qualified parties based on the documents to be submitted by them along with the written request for tender documents. Issuance of the tender documents does not mean that the party is qualified.
9. The department shall not be held responsible for any postal delay.
10. Earnest Money will be refunded to the unsuccessful parties and bear no interest.
11. There will be no arbitration clause.
12. No tender will be issued or submitted by postal means.
13. The cost of tender shall be deposited in the form of the cash in the office of FM(Pay), Koyla Bhawan. Earnest money shall be deposited either in form of cash in the office of F.M.(Pay), Koyla Bhawan or Bank Draft of Nationalised Bank in favour of "Bharat Coking Coal Limited" payable at Dhanbad.
14. The tender will be valid for 120 days from the date of opening of price bid or revised price bid, whichever is later.
15. The tenderers have to submit permanent Account Number of Income Tax (PAN) and documents relating to Sales Tax registration/TIN in Techno-Commercial bid.
16. The tenderers must ensure that submission of photo copies of documents submitted in tenders are legible.
17. The tenderer must submit and Affidavit as per format issued along with tender documents. Non submission will lead to cancellation of tender.
18. The tenderer must also give a declaration to be submitted along with Techno Commercial Bid that they have not been banned or delisted by any Govt./ Quasi Govt. agencies/PSU'S.
