3. <u>GENERAL TERMS:-</u>

- Tender will be allowed four (4) grace days only on Sunday for repair and Maintainence of the vehicle which means the vehicle will always be available during the working days of the Mine. This may be altered if the Mine is worked on Sunday.
- (ii) Tenderers will be responsible for all maintenance & other expenses for running the van.
- (iii) The Van will run within District of Dhanbad only.
