**TERMS & CONDITIONS**

- a) The tenderer shall furnish details of vehicles (To be deployed by for contract job) with their Registration No, Name & Address of their owners
- b) In case vehicle is not owned by the owner, the detail with Registration, description and legal documents like power of Attorney from the owner authorizing the tenderer to ply the vehicle under contract is to be submitted
- c) The vehicle deployed shall be inspected/ approved by an authorized person as decided by the management.
- d) The driver deployed on the vehicle will be in proper outfit and in uniform while on duty as prescribed by the management.
- e) The uniform & accessories are to be provided by the agency at their own cost.
- f) The driver should possess valid Commercial driving license in his name and should be able to drive vehicle efficiently and conversant with the traffic rules.
- g) The agency will have to abide by the provisions of all statutes including labour, taxation, and other law applicable to its establishments during the period of its engagement and shall be responsible and accountable for breach or violation of any of the provisions, act, rules, regulation, notification, circulars issued from time to time by Govt of India or State Govt. The agency shall provide an undertaking to this effect prior to commencement of the job indemnify BCCL, Dhanbad against any breach if statutes/Law etc.
- h) Details of office establishment of the agency/ owner for emergency contact such as mailing address and telephone/mobile numbers should be submitted along with tender paper.
