1. Tender papers/documents can be had from the office of the SE(c), WD Saraidhella on the written request on any working day from 28.02.09 to 05.03.09 on payment of cost of tender paper with finance departments.
2. Tender will be received upto 3.00 PM on 06.03.09 and the part-I of the tender (i.e. Technical bid) will be opened on the same day at 3.30 PM. The part- II i.e. commercial bid will be opened after the department is satisfied that the criteria fixed are fulfilled and the earnest money is deposited.
3. Eligibility criteria:-
 - a) The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar works during last 7 (seven) years ending last day of month previous to the one in which bid application are invited (i.e. eligibility period) should be either of the following:

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

Or

Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

Or

One similar completed works each costing not less than the amount equal to 80% of the estimated cost.
 - b) Average annual financial turnover of civil works during the last 3 (three) years ending 31st march of the previous financial year should be at least 30% of the estimated cost.
 - c) Similar works means: A steel structural works.

4. E money is to be deposited with the associate bank of company or any nationalized bank in favour of Bharat Coking Coal Ltd. payable at Dhanbad.
5. All taxes applicable shall be born by contractor.
6. The validity of the tender will be 120 days from the date of opening of price bid or revised price bid, if any.
7. The management of BCCL reserves right to reject any or all the tenders without assigning any reasons whatsoever and to split up and distribute the work amongst the tenderers.
8. The tenderer has to submit PAN No & TIN No.
9. Conditional tender will not be accepted.
10. The contractors have to acquaint themselves with site conditions before quoting their rates.
11. Structural steel material will be provided by BCCL from Washery store free of cost.
12. Contractor at his own cost will arrange gas and Electrode.
13. Contractor at his own cost will arrange tool and Tackles.
14. completed Bid documents will be available on the web-site for the purpose of Downloading & tenders submitted such downloaded bid documents shall be considered valid For participating in then tender papers.
