#### **ELIGIBILITY CRITERIA FOR ISSUANCE OF TENDER PAPER:**

The intending tenderers must have in its name, experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period) and the same should be either of the following:

 Three similar works completed successfully each costing not less than the amount equal to 40% of the estimated cost.

Or

Two similar works completed successfully each costing not less than the amount equal to 50% of the estimated cost.

One similar works completed successfully costing not less than the amount equal to 80% of the estimated cost.

- 2. Average annual financial turn over during the last 3 years ending 31<sup>st</sup> March of the previous financial year should be at least 30% of the estimated cost.
- 3. Similar work means the tenderer should have experience of civil construction work.
