### ELIGILIBITY CRITERIA FOR ISSUENCE OF TENDER PAPER:

- 1. The intending tenders must have in its name, experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which bid application are invited (i.e eligibility period) and same should be either of the following:
