ELIGIBILITY CRITERIA:

- 2) Average Annual financial turnover of "W/B" related works during the last 3 years ending 31st march of the previous financial year, should be at least 30% of the estimated cost.
- 3) The intending Tenderer must have experience of having successfully completed similar works during last seven years ending last day of month previous to the one on which applications are invited (i.e. eligibility period) should be either of the following
 - a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

b) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost

or

- c) One similar completed work each costing not less than the amount equal to 80% of the estimated cost.
- Note: 1) Provision under eligibility criteria under Sl. No. 2 shall also include those similar works that have been started earlier than eligibility period of tender but completed during the eligibility period as per NIT.
 - 2) As per eligibility criteria under Sl.No. 2 prequalification should be done based on experience of the successfully complete works and not on experience of works in progress.
 - completed sealed tender (Part-I & Part-II) Technical bid part-I and price bid part –II, should be submitted on or before 4.p.m. in the office of the Area Manager(E&M), Sijua Area and will be opened on the same day at 4.30 p.m. in the presence of attending tendereres of their authorized representative. Only part-I will be opened on 31.3.10 and part-II will be opened only after acceptance of part-I (Technical bid)
 - 5) Management of BCCL reserves the right to reject any or all of the tenders without assigning any reasons what so ever and to split up and distribute the work among the tenderers
 - 6) Earnest money should be deposited in the form of cash or bank draft of local nationalize bank in favour of Bharat Coking Coal Limited payable at Dhanbad. Paper money receipt should be enclosed with the tender document part-I without this tender will be rejected
 - 7) Issuance of tender document does not mean that the parties are considered qualified late or delayed tenders will not be accepted.
 - 8) Experience as given in the eligibility criteria should be in the name of and style of firm in which tender is filled. Experience in some other firm/company will not be considered for this purpose.
 - 9) The validity of tender will be 120 days from the date of opening of price bid or revised price bid if any.
 - 10) Conditional tenders will not be considered.
 - 11) The complete bid documents will be available on BCCL Web site "http://bccl.cmpdi.co.in" for the purpose of downloading and tender submitted on such down load bid documents shall be considered valid for participating in the tender process.
 - 12) The bidders who will down load the tender documents from the web site of the company, will be required to pay the cost of tender paper (application fee) by bank draft as per NIT, at the time of submission of tenders.
 - 13) The bidders will be required to submit and undertaking that they will accept the tender documents as available in the web site and their tender shall be rejected, any tempering in the tender documents is found to be done at the time of opening of tender.
