1) Eligibility Criteria :-

(a) The intending tender must have in its name as prime contractor experience of having successfully completed under ground work during 7 (seven) years ending last day of the , month previous to the one in which bid application are invited (i.e. eligibility period) should be either of the following :-
Three similar completed works is costing no less than the amount equal to 40 % of the estimated cost.

OR

Two similar completed work is costing no less than the amount equal to 50% of the estimated cost.

OR

One similar completed work is costing no less than the amount equal to 80% of the estimated cost.

(b) Average annual financial turn over of mines works during the last three years ending 31st March of the pervious financial year should be at least 30% of the estimated cost.

© Similar work means : under ground work.

NOTE (i) Provision under eligibility criteria 1. (a) shall also include those similar work which have been started earlier than eligibility period of tender but completed during the eligibility period.
