Issue of tender documents will be done on all working days during working hours except on Sunday & holidays. In the event of the specified date for submission, opening of bid declared a holiday by the employer, the bids will be received/opened on the appointed time on the next working day.

Date and time of opening of tender : 13.03.2009 AT 3.30 p.m.

1) Eligibility Criteria :-

(a) The intending tender must have in its name as prime contractor experience of having successfully completed similar work during 7 (seven) years ending last day of the month previous to the one in which bid application are invited (i.e. eligibility period) should be either of the following :-

Three similar completed works is costing no less than the amount equal to 40 % of the estimated cost.

OR

Two similar completed work is costing no less than the amount equal to 50% of the estimated cost.

OR

One similar completed work is costing no less than the amount equal to 80% of the estimated cost.

(b) Average annual financial turn over of civil works during the last three years ending 31<sup>st</sup> March of the previous financial year should be at least 30% of the estimated cost.

© Similar work means : Civil surface work.

NOTE (i) Provision under eligibility criteria 1. (a) shall also include those similar work which have been started earlier than eligibility period of tender but completed during the eligibility period as per NIT.

(ii) As per eligibility criteria specified under S.L. No. 1(a) Pre-qualification shall be done based on experience of successfully completed works and

2) Tender document can be had from the office of the General manager, Lodna Area, Lodna Area civil Engineering Department, P.O. Khas Jeenagora, dist. Dhanbad from 13.03.09 on deposition of requisite cost of tender paper in form of cash or the Cashier, Lodna Area.

3) Complete sealed tender document (Part "A" & Part "B") should be submitted at the same time. Part 'A' shall consist of any deviation from terms and conditions of the tender and additional terms and condition if asked for, technical bid and credentials. Part "B" shall consist of tender documents as sold to the Tenderers duly filling in rates, amounts etc. i.e. price bid. The earnest money deposit is to be submitted in a separate envelope altogether superscribing "Earnest Money Deposit" and not inside the envelope containing part-"A" or part-"B" of the Bid. The part -"A" &

part-"B" should also be put into separate sealed envelopes superscribed as such. Thereafter all the three envelopes should be submitted in a sealed envelope with appropriate superscription.

The Tender will be received on 13.03.2009 upto 3.00 P.M. by the tender committee in the tender box at Civil Deptt. Lodna Area. And will be opened at 3.00 P.M. on the same day i.e on 13.03.2009 The Part -II will be opened only after the department is satisfied that the criteria fixed are fulfilled and also the earnest money is deposited i.e. on acceptance of Part- "A"

4) In case where tender documents are requested for transmission by post, these should be dispatched A.D. The department is not responsible for any postal delay in such cases.

5) The earnest money is to be deposit as per detail given in the tender documents.
