- [2] The tenderers must have average annual financial turn over civil works during last three years ending 31st March of previous financial year i.e. in 2005-06, 2006-07 & 2007-08 should be least 30% of the estimated cost.
- [3] Rate to be quoted in % above/below of the estimated cost both in figure and words in BCCL prescribed forms.
- [4] The contractor have to acquainted with the side condition.
- [5] All Taxes as applicable will be born by the Contractor.
- [6] The Earnest Money to be deposited in cash with associated finance in Sijua Area or in the form of A.C. Payee Demand Draft only in favour of B.C.C.L., DILIANBAD, Earnest Money bears no interest and may be refund only to the unsuccessful tenderers in due course on completion of formalities.
