Receipt and submission of Tender - The tender will be received on 21.04.2009 upto 3.00 P.M. at C.I.S.F. Post, near Koyla Bhawan gate, Koyla Nagar, BCCL, Dhanbad. Sealed tender documents (part I & II)

complete in all respect should be submitted as follows :-

Part-I shall consist of terms and conditions of the tender, additional terms and conditions if any, technical bid and tenderer's credentials & sealed in a envelope scribing as Part-I. Part-II shall consist of tender documents as sold to the tenderers duly filled in for rates, amounts etc. i.e. price bid and sealed in a envelope scribing as Part-II. Similarly the Earnest money deposit is to be submitted in a envelope super scribing as "Earnest Money Deposit", and not inside the envelope containing Part-I or Part-II of the Bid. Thereafter all the three envelopes should be submitted in a sealed envelope with appropriate superscription.

3. Opening of Tender - The Part-I only of the tenders will be opened at 4.00 P.M. on 21.04.2009 itself in presence of the intending tenderer or their authorized representative in the Office of General Manager (Constn.), Civil Engineering Department, HQ., Koyla Nagar, Dhanbad and the part-II will be opened only

after acceptance of part-I.

In the event of the specified date for submission/opening of bids being declared a holiday the bids will be received/opened on the appointed time on the next working day.

4. Eligibility criteria :-

The intending tenderer must have in its name as a prime contractor or as a sub-contractor provided there is a sub-contract provision in the original contract awarded to the prime contractor, experience of having successfully completed similar works during last 7 (seven) years ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period) should be either of the following :-

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost. OR Two similar completed works each costing not less than the amount equal to 50% of the estimated cost. OR One similar completed work costing not less than the amount equal to 80% of the estimated cost.

Similar work means: Construction or Repair & maintenance of Residential Building.

Average annual financial turnover of civil works during the last 3 (three) years, ending 31st March of

the previous financial year, should be at least 30% of the estimated cost.

The intending tenderer must submit documentary evidence in support of (4) (a) & (b) above in the form of certified copy of work order, completion certificate, payment certificates/ vouchers etc. indicating the period of work for which the payment has been made, duly signed by him/them.

c) The earnest money is to be deposited as per detail given in the tender documents.

 Sales Tax clearance certificate copy attested by a Gazetted Officer of the Govt. (Central or State) & TIN No.

e) The tenderers have to submit Permanent Account No. of Income Tax (PAN No.).
