Eligibility criteria

- 1) The intending Tender must have in its name experience of having successfully completed similar works during last 7 (Seven) years ending last day of the month previous to the one in which bid application are invited (i.e. eligibility period) should be either of the following :-
 - i) There similar completed works each costing not less than the amount equal to 40% of the estimated cost or
 - ii) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost or
 - iii) One similar completed work costing not less than the amount equal to 80% the estimated cost.
- 2) Average Annual financial turnover of Civil work during the last 3 (Three) years ending 31st March of the previous financial year (i.e during 2005-06 to 2007-08) should be at least 30% of the estimated cost.
- 3) The Tender has to submit Permanent Account No. of Income Tax (PAN) and particulars of registration Number/Tin with appropriate Sales Tax authorities.
- 4) Similar work means :- Overhauling, cleaning, erection & painting R.G. Filter Plant.
- 5) The Tender documents can be had from the office of Supdt. Engineer (Civil) W.J. Area, Maduha Group on deposition of requisite cost of Tender paper in form of cash with cashier, W.J. Area, Mohuda group on 16.04.2009 & 17.04.2009 during office hours.
- 6) Completed sealed tender documents (Part –I & Part – II) Technical bid (Part – I) and Price bid (part - II) should be submitted at the time. The Tender will be received upto 11.00 A.M. on 18.04.2009 in the office of Supdt. Engineer (Civil) W.J. Area, Mohuda Group and will be opened at 11.30 A.M. on the same day in presence of the intending Tender or their authorized representative. Only Part –I of the Tender will be opened on 18.04.2009 Part –II will be opened only after the department is satisfied that the criteria are fulfilled and also the Earnest money is deposited i.e. on acceptance of part –I.

- 8) No Tender will be issued or submitted by Postal means. The Earnest money should be deposited in form of Bank Draft of a nationalize Bank in favour of BHARAT COKING COAL LIMITED, payable at Dhanbad. The Earnest money is to be deposited as per details given in the Tender document.
- 9) Conditional Tender will not be accepted.
- 10) No materials will be supplied by the department for the work and will be responsibility of the Contractor for procurement of the same at his own cost.
- 11) Issuance of Tender document does not mean that the parties any considered qualified. Late or delayed Tender shall not be accepted.
- 12) The experience as given in the eligibility criteria should be in the name & style in which tender is filled. The experience in the name of some other firm/company will not be considered for this purpose.
