ELIGIBILITY CRITERIA :

1. i) The intending tenderer must have in its name as prime supplier having experience of supplied successfully completed similar type of item during last 03(three) years ending last day of the month previous to the one in which offer is invited i.e. 31-03-2009, should be either of CTI/PSU/Any Govt. Department.

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost,

OR

Two similar completed works each costing not less than the amount equal to 60% of the estimated cost.

OR

One similar completed works each costing not less than the amount equal to 80% of the estimated cost.

- ii) Similar work means :-Supply of Water Cooler.

The tender documents can be had from the Office of General Manager (Admin.), Koyla Bhawan, Dhanbad from 07-05-2009 on production of credential in support of eligibility criteria & relevant terms of NIT & thereafter, requisite cost of tender documents in the form of cash or Bank Draft of nationalised Bank in favour of Bharat Cooking Coal Limited, payable at Dhanbad.

The first part "Part-I i.e. Techno Commercial Bid" should contain the technical details with technical specification credential of work done and commercial terms without price. The second Part- "Part-II i.e. Price Bid" sealed separately should contain the details of -i.e. only. Both the envelope should be super scriped with one tender reference & name over Part-I & Part-II respectively.
