1. Eligibility criteria:-

a) The intending tenderer must have in its name as a prime contractor experihaving successfully completed similar works during last 7 (seven) years ending of month previous to the one in which bid applications are invited (i.e. eligibility should be either of the following :- :

Three similar completed works each costing not less than the amount equal to 40° estimated cost.

Two similar completed works each costing not less than amount equal to 50%

One similar completed work costing not less than amount equal to 80% of the estimacost,

- b) Average annual financial turn over of works during the last 3 (three) years, ending 31 March of the previous financial year, should be at least 30% of the estimated cost.
- e) Similar work means: Making isolation, Ventilation stopping and retaining wall.
- Note: (1) Provision under eligibility criteria No.1(a) shall also include those similar work which have been started earlier than eligibility period of tender but completed during the eligibility period as per NIT.
 - (2) As per eligibility criteria specified under No.1 (a) Pre-qualification shall be done based on experience of successfully completed works and not on experience of work in progress.
- 3) The tender documents can be obtained from the office of the Area Survey Officer, W.J.A., Mohuda Group, Dhanbad from 26.05.2009 to 05.06.2009 on deposition of requisite cost of tender paper in form of cash, or bank draft of Nationalized Bank in favour of Bharat Coking Coal Limited, payable at Dhanbad.
- 4) Completed sealed tender documents (Part I & II) i.e. Technical/commercial bid (Part I) & Price bid (Part II) should be submitted at the same time. The tender will be received on 09.06.2009 upto 3.00 P.M. in the office of Area Survey Officer, W.J.A , Mohuda Group, Dhanbad and will be opened at 3.30 P.M. on the same day in presence of the intending tenderer or their authorized representative to be present. Only part-I will be opened on 09.06.2009. The part-II will be opened only after the department is satisfied that the criteria fixed are fulfilled and also the earnest money is deposited i.e. on acceptance of part-I.
- 5) In case where tender documents are requested for transmission by post, these would be dispatched by Registered post with A.D. The department is not responsible for any postal delay in such cases.
- The earnest money is to be deposited as per detail given in the tender documents.
- Conditional tenders will not be accepted.
- Issuance of tender documents does not mean that the parties are considered qualified.
- 9) The experience as given in the eligibility criteria should be in the name and style in which tender is filled. The experience in the name of some other firm/company will not be considered for this purpose.
- 10) The validity of the tender will be 120 days from the date of opening price bid or revised price bid if any.
- 11) The management of BCCL reserves right to reject any or all the tenders without assigning any reasons what so ever and to split up and distribute the work amongst the tenderers.
 - 12) The tenderers has to submit Permanent Account Number of Income Tax (PAN No.), Sales Tax Registration/VAT & Service Tax Registration.
