1) Eligibility Criteria :-

Three similar completed works is costing no less than the amount equal to 40 % of the estimated cost.

OR

Two similar completed work is costing to less than the amount equal to 50% of the estimated cost.

OR

One similar completed work is costing to less than the amount equal to 80% of the estimated cost.

Similar Work means: Civil Surface work

(b) Average annual financial turn over of civil works during the last three years ending 31st March of the pervious financial year should be at least 30% of the estimated cost.
