NOTICE INVITING TENDER:-

- Sealed tenders are invited on percentage above/below basis from bonafide, experienced and resourceful contractors for the following work:-

ELIGIBILITY. CRITERIA:-

- The intending tenderers must have in its name, experience of having successfully completed similar works during last 7 years ending last day of month, previous to the one in which bid application are invited (i.e eligibility period) should be either of the following:-
 - Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.
 - Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.
 - One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- Average annual financial turn over of civil works during last three years ending 31st March of the previous financial year (i.e.during 2006-07 to 2008-09) should be at least 30% of the estimated cost.
- Similar work means that the tenderer should have experience of civil Construction Repair/maintenance work(tiles work).
- Conditional tenders will not be accepted.
- Tenders are to be submitted separately in two sealed covers containing (i) Techno commercial bid and (ii) price bid. The techno-commercial bid should contain the proof of eligibility criteria as fixed above the earnest money and details of TIN&PAN no. The part -I will be opened on 15.06.2009 at 3.30 pm. The part-II containing the price bid will be opened by the committee only after acceptance of Part-I.
- The tender documents can be had from the office of S.E(C) JNTA from 12.06.2009 to 12.06.2009 during office hours only on written request and production of credential in support of the eligibility for issuance of tender documents.
- The experience given in the eligibility criteria should be in the name and style in which tender is filled. The experience of the partner if any, in name or firm/company will not be counted for the purpose.

8. The tender will be received on 15.06.2009 up to 3.00pm in the office of Incharge JNTA, and Part-I will be opened at 3.30pm on the same day in the office of Incharge JNTA in presence of the intending tenderers or their authorized representatives.
9. The Management of BCCL reserves the right to reject any or all tenders without assigning any reason whatever or to split up or distribute the work among the tenderers.
10. The tender will be finalized as per the guideline of CIL's manual for Civil Engg. works. The manual will be available for reference with office of S.E(C) JNTA, during sell of the tenders documents.
11. The tender documents will be issued to the prime facie qualified parties based on the documents to be submitted by them along with the written request for tender documents. Issuance of the tender documents does not mean that the party is qualified.
12. The Department shall not be held responsible for any postal delay.
13. Earnest money will be refunded to the unsuccessful parties and bear no interest.
14. There will be no arbitration clause.
15. No tender will be issued or submitted by postal means.
16. The earnest money shall be deposited in form of cash in the office of F.M(Pay), Koyla Bhawan or Bank draft of Nationalised Bank in favour of "Bharat Coking Coal Limited" payable at Dhanbad. The earnest money is to be deposited as per details given in the tender documents.
17. The tender will be valid for 120 days from the date of opening of price bid or revised price bid, whichever is later.
18. The tenderers have to submit permanent Account number of Income tax (PAN) and documents relating to sales Tax Registration /TIN in Techno-Commercial bid.
