1. Eligibility criteria:-

a) The intending tenderer must have in its name as a prime controller experience of having successfully completed similar works during last 7 (seven) years ending last day

of month previous to the one in which bid applications are invited (i.e. eligibility period) should be either of the following in

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

Or

Two similar completed work each costing not less than amount equal to 50% of the estimated cost

Or

One similar completed work costing not less than amount equal to 80% of the estimated cost.

- b) Average annual financial terrover of works during the last 3 (three) years, ending 31" March of the previous financial year, should be at least 30% of the estimated cost.
- c) Similar work means: Making isolation, Ventilation stopping and retaining wall. in U/G.

Note: (1) Provision under eligibility criteria No.1(a) shall also include those similar work which have been started earlier than eligibility period of tender but completed during the eligibility period as per MIT.

(2) As per eligibility criteria specified under No.1 (a) Pre-qualification shall be done based on experience of successfully completed works and not on experience of work

in progress.
