(b) Average annual financial turn over of civil works during the last three years ending 31st March of the pervious financial year should be at least 30% of the estimated cost.

© Similar work means : Civil surface work .

NOTE (i) Provision under eligibility criteria 1. (a) shall also include those similar work which have been started earlier than eligibility period of tender but completed during the eligibility period as per

NIT.

(ii) As per eligibility criteria specified under S.L. No. 1(a) Pre-qualification shall be done based on experience of successfully completed works and
