01. It should be DGMS Approval must be valid on the date of Opening of Tenders.
02. The manufacturer shall always obtain a quality certificate of the materials, Metals, chemicals, components, parts and accessories purchased from the suppliers, which shall be supplied to the Consignee.
03. The manufacturer shall furnish all the relevant information in respect of chemical composition, properties, mechanical parameters and specifications or any other information or reports pertinent to their products to the Consignee.
04. The Cement Capsule and its constituent shall be exactly of the same quantity, quality and composition % given in the application for approval from DGMS and a notarized copy of the same shall be supplied with each lot of Cement Capsules supplied to the Consignee.
05. The put out strength (Tensile Strength) of the Roof boat grouted with full column cement capsule shall not be less than 8 tonnes.
06. Two percent of the samples of Cement Capsule manufactured, jointly sampled by the users & manufacturer, shall be subjected to prescribed examination and testing at an established and accredited Test House CIMFR/ISMU and the cost of testing will be borne by the supplier/manufacturer. The Cement Capsules destroyed in the test shall be replaced by the supplier/manufacturer free of cost. However if supplier does not turn up for conducting Test even after two reminder users will get the materials tested as prescribed above.
07. The examination and testing so prescribed shall be carried out in the presence of the representative from the manufacturers and users who shall witness the tests and examinations and sign thereon the tests and examination reports.
08. The chemicals of the materials and substances used in the product shall be bio-degradable, non-ozone depleting and non-toxic in nature.
09. The manufacturer shall arrange to provide clear instructions for use, safety data sheet, codes of safe practices for storage and use of the product.
10. The schedule of checking, checklist and other relevant information shall also be provided by the manufacturer to the users on every consignment of supplies.
