2. Tender will be received upto 3.00 PM on 30.07.09 and the part-I of the tender (i.e. Technical bid) will be opened on the same day at 3.30 PM. The part- II i.e. commercial bid will be opened after the department is satisfied that the criteria fixed are fulfilled and the earnest money is deposited.
3. Eligibility criteria:-
 - a) The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar works during last 7 (seven) years ending last day of month previous to the one in which bid application are invited (i.e. eligibility period) should be either of the following:
Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.
Or
Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.
Or
One similar completed works each costing not less than the amount equal to 80% of the estimated cost.
 - b) Average annual financial turnover of civil works during the last 3 (three) years ending 31st march of the previous financial year should be at least 30% of the estimated cost.
 - c) Similar works means: Roof tar felting works. Only manufacturers of roof tar felting having ISI license are eligible. They have to submit relevant ISI license/certificate in the Technical bid(Ist part).
4. E/money is to be deposited with the associate finance in shape of cash or bank draft drawn on any nationalized bank in favour of Bharat Coking Coal Ltd. payable at Dhanbad.
5. All taxes applicable shall be born by contractor.
6. The validity of the tender will be 120 days from the date of opening of price bid or revised price bid, if any.
