3.1 Tender must be submitted in Two part system (i.e. Credentials in Envelope I and Rate part only in Envelope II) in the office of the Supdt. Engg. (C), Satabdi CCP upto 3.30 P.M. on 30.11.09.

Part-I of the tenders will be opened on same day at 4.00 P.M. in presence of the tenderers or their authorized representatives. However, Part-II may be opened on same day (of those tenderers only who qualify for opening of their rate part as per eligibility criteria/any other day with intimation to the qualified bidders).

4) The minimum eligibility criteria for consideration for award of work of the contract shall include the following.

4.1(a) The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar work during last 7 (seven) years ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period) should be either of the following.  
Three similar completed works each costing not less than the amount equal to 40% of the estimated cost

OR

Two similar completed works each costing not less than the amount equal to 5% of the estimated cost

OR

One similar completed work costing less than amount equal to 80% of the estimated cost.

4.1(b) Average annual financial turnover of civil works during the last 3 (three) years ending 31st March of the previous financial year should be at least 30% of the estimated cost.

4.2 Similar work means Rep/maj t.o.f Building/civil works.
