General instruction for submission of Discount Bic: :-

1. The Contractor is required to submit his their Discount Offer is sealed cover giving reference to 1-18 notice number and date as well clearly supersor sting the cover with the name of the work.

The Bidders shall fill in rates and prices for all items of the works described in the bill of quantities. Corrections, if any, shall be made by crossing out, initialing, dating

of Bids and recommendations for the award of the Contract shall not be disclosed to Bidders or at a other persons not officially concerned with such process until the award to the successful Bidder has been announced. Any effort by a Bidder to rejection of his Bid.

7. Bids determined to be substantially responsive will be checked by the Employer for any arithmetical errors. Firois will be corrected by the Employer as follows:-

a) Where there is a discrepancy between the amounts in figures and in words, the amounts in words will govern; and

b) Where there is discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern.

c) Discrepancy in totaling or carry forward in the amount quoted by the Contractor shall be corrected.

8. The tendered sum so corrected and altered shall be substituted for the sum originally tendered and considered for acceptance instead of the origin I sum quoted by the Bidder along with. The amount stated in the bid will be adjusted by the employer in accordance with the above procedure for the correction of errors and, shall be considered as historic mediately.

9. The Bidder, who's Bid, has been accepted, will be notified of the award by the Employer prior to the expiration of the Bid validity period by Cable, Telex or conditions of Contract called the "Letter of Acceptance") w. I state the sum that the Employer will pay the Contractor in consideration of execution and completion of the work by the Contractor as prescribed by the Contract (hereinafter and in the Contract of Contract Price"). The notification of award will constitute the formation of Contract, subject only to the furnishing of a Performance Security/Initial Security Deposit in accordance conditions of SOR-2009.

10. Contractors are to employ, to the extent possible, only local project affected people and pay wages not less than the minimum wages fixed by the Law of the Land.

11. Matter relate I to any dispute or difference arising out of this tender and subsequent contract aw redd based on the Bid shall be subjected t by jurisdiction of the Dhanbad Court only.

12. Penal action in case of failure on the part of the Bidder. The registration of the SOR Contractor shall stand cancelled and withdrawn in case the successful Bidder, fails within the specified time limit to furnish the required performance Security / Initial Security Deposit, sign the Agreement and the Bidder does start the work within stipulated time. Once a SOR registered Contractor is penalized on this count, he may as a special case appeal to the Director Technical, BCCL, for Re-registration for which the de-list d SOR Contractor will have to deposit Rs. 10,000/- towards re-registration for the same. However, re-registration of a de-listed SOR Contractor will be on the sole discretion of BCCL Management.

The Company is not under any obligation to accept the Lowest Bid and reserves the right to reject any or all Discount Bids without assigning any reasons what-so-ever and also to distribute the work and allot the work/s to more than one Bidder at its sole discretion.
