ELIGIBILITY, CRITERIA;-

- The intending tenderers must have in its name, experience of having successfully completed similar works during last 7 years ending last day of month, previous to the one in which bid application are invited (i.e eligibility period) should be either of the following:
 - a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.
 - b) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.
 - c) One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- Average annual financial turn over of civil works during last three years ending 31st
 March of the previous financial year (i.e.during 2006-07 to 2008-09) should be at least
 30% of the estimated cost.
- 3 Similar work means that the tenderer should have experience of sanitation works of Garbage cleaning/sweeping.
