NOTICE INVITING TENDERS

Sealed tender in two parts (part I & II) are invited from experienced and eligible contractors for the following work/s :-

1. Availability of tender documents. - Tender documents can be had from the office of the G. M. (Constn.), Civil Engineering Department, HQ., Koyla Nagar, Dhanbad on deposition of requisite cost of tender paper in cash or bank draft of Nationalized bank drawn in favour of Bharat Coking Coal Ltd., payable at Dhanbad during office hours on all working days from 28.08.2009 to 03.09.2009

2. Receipt and submission of Tender - Sealed tender documents (part I & II), as detailed below, complete in all respect will be received at C.I.S.F. Post, Koyla Bhawan gate, Koyla Nagar, BCCL, Dhanbad on 07.09.2009 upto 3.00 P.M. Part-I shall consist of tender document issued to the tenderer and tenderer's credentials, sealed in a envelope superscribing as Part-I, Part-II shall consist of bill of quantity as issued to the tenderers duly filled in for rates, amounts etc. and sealed in a envelope superscribing as Part-II. Similarly the Earnest money deposit is to be submitted in a envelope super scribing as "Earnest Money Deposit". Thereafter all the three envelopes should be submitted in a sealed envelope with appropriate superscription.

3. Opening of Tender - The Part-I of the tenders will be opened at 4.00 P.M. on 07.09.2009 itself in presence of the intending tenderer or their authorized representative in the Office of General Manager (Constn.), Civil Engineering Department, HQ., Koyla Nagar, Dhanbad. Part-II of the tender will be opened only after acceptance of Part-I.

In the event of the specified date for submission/opening of bids being declared a holiday the bids will be received/opened on the appointed time on the next working day.

4. Eligibility criteria :-

a) The intending tenderer must have in its name as a prime contractor or as a sub-contractor provided there is a sub-contract provision in the original contract awarded to the prime contractor, experience of having successfully completed similar works during last 7 (seven) years ending last day of month previous to the one in which bid applications are invited should be either of the following :-

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

OR

Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

OR

One similar completed work costing not less than the amount equal to 80% of the estimated cost.

Similar work means : Structural Steel Work

b) Average annual financial turnover of civil works during the last 3 (three) years, ending 31st March of the previous financial year, should be at least 30% of the estimated cost.

Intending tenderer must submit documentary evidence in support of (4) (a) & (b) above in the form of certified copy of work order, completion certificate, payment certificates/ vouchers etc. indicating the period of work for which the payment has been made, duly signed by him/them.

- c) The earnest money is to be deposited as per detail given in the tender documents.
- d) Attested Sales Tax clearance certificate & ITN No.
- e) The tenderers have to submit Permanent Account No. of Income Tax (PAN No.).
- f) Conditional tenders will not be accepted.
- g) Issuance of tender documents does not mean that the parties are considered qualified.
- h) The validity of the tender will be 120 days from the date of opening price bid or revised price bid if any.
- i) The management of BCCL reserves right to reject any or all tender or split the work among two or more tenderers with out assigning any reasons whatsoever.
