**ELIGIBILITY CRETERIA:**

3. The intending tenders must have its name s a prime contractor Experience of having successfully completed similar works during last 07 Seven) years ending last day of month) previous to the one in which bid application are invited (i.e. eligibility period) should be either of the following.

Note: Similar works means Civil Surface work For Sl. No. 2

- (i) Three Similar complete works each Costing not less than than amount equal to 40% of the estimated Cost .

OR

- (ii) Two Similar complete works each Costing not less than the amount equal to 50% of the Estimated cost

OR

- (iii) One Similar Complete work Costing not less than the amount equal to 80% of the estimated cost

4. Average annual financial turn over of Civil Works during last three years ending 31 st March of the previous financial year should be at least 30% of the estimated cost.

NOTE: Provision under eligibility criteria under Sl.No. 1 shall also include those similar works which have been started earlier than eligibility period of tender but completed during the eligibility priod as per NTT.

- ii) A s per eligibility criteria specified under sl.no. 1 pre- qualification shall be done based on experience of the successfully completed works and not on experience of works in progress.
