Eligibility Criteria :-

a) The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar works during last 7 (seven) years ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period) should be either of the following :-

Three similar completed works each costing not less than the amount equal to 40% of the

estimated cost.

Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

One similar completed work costing not less than the amount equal to 80% of the estimated cost.

- Average annual financial turnover of civil works during the last 3 (three) years, ending 31st March of the previous financial year, should be at least 30% of the estimated cost.
- Similar work means, Drilling bore holes of 8 inch dia. & 180 Mtr. deep.
- Note:- (i) Provision under eligibility criteria I(a) shall also include those similar work which have been started earlier than eligibility period of tender but completed during the eligibility period as per NIT. (ii) As per eligibility criteria 1(a) Pre-qualification shall be done based on experience of successfully completed works and not on experience of work in progress.
- The Agency should possess Rotary/DTH Drill Machine on ownership or in any other capacity having full control over it.

The Earnest money deposit is to be submitted in a separate Envelope altogether superscribing "Earnest Money Deposit", and not inside the envelope containing Part-I or Part-II of the Bid The Part I & Part-II should also be put into separate sealed envelopes superscribed as such.
