3. Tender must be submitted in **Two part system** in two separate sealed envelopes. ( Other credentials in Envelop Ist and rate part only in Envelop II ) in the office of the Area Civil Engineer P.B.Area up to **3.30 PM on 04.01.2011**. **Or** at CISF Post near Koyla Bhawan Gate , Koyla Nagar, BCCL Dhanbad.

**Part I** of The tender will be opened **on 05.01.2011** same day **at 11.30 AM** onwards. In presence of tenderers or their authorised representatives. The date of opening of the 2<sup>nd</sup> Envelop (Part- II) of the tenders shall be communicated in due course after consideration of Ist envelop (Part – I ).

4. The minimum eligibility criteria for consideration for award of work of the Contract shall include the following.

4.1(a) The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar works during last 7 (seven) years ending last day of month previous to the one in which bid application are invited (i.e. eligibility period) should be either of the following :-

> Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

**Or**

> Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

**Or**

> One similar completed work costing not less than the amount equal to 80% of the estimated cost

4.1(b) Average annual financial turnover of civil works during the last 3(three) years ending 31<sup>st</sup> March of the previous financial year , should be at least 30% of the estimated cost.

4. 1. Similar work means: **Underground Civil works** .

4.2. Earnest money can be deposited in the form of Cash or BG / DD in favour of Bharat Coking Coal Limited payable at Dhanbad from any nationalized / scheduled bank acceptable to the company. Tenders not accompanied with earnest money are liable for outright rejection.

**8.** The experience as given in eligibility criteria should be in the name & style in which the tender submitted. The experience of partner, if any, in the name of other firms / company will not be considered for this purpose.

**10.** The responsibility for arrangement of all input materials required for the work shall be mainly with the contractor.
