The Tender will be received on dated 21.01.2011 from 10.00 AM to 1.00 PM in tender box at (1). CISF post near Koyla Nagar, BCCL, Dhanbad. (2) CISF'S office of EJ Area and will be opened on 25.01.2011 at 4.00 Pm in the office of the A.C.E, E.J.Area.

**ELIGIBILITY CRITERIA**

a). The intending tender must have in its name as a prime contractor experience of having successfully completed similar works during last 7(seven) years ending last days of the month previous to the one which bid applications are invited should be either of the following:-(1). Three similar completed works each costing not less than 40% of the estimated cost. Or (2). Two similar completed works each costing not less than 50% of the estimated cost or (3). One similar completed works costing not less than 80% of the estimated cost. **Similar work means: Construction of Isolation stopping.**

b). Average annual financial turnover of civil works during the last three years, ending years, ending 31<sup>st</sup> . March of the previous financial should be at least 30% of the estimated cost.

2. the tender documents can be had from the office of the undersigned during the period mentioned above on deposited of requisite cost of tender paper in form of cash bank draft of any nationalized bank/scheduled commercial bank approved by reserve bank of India in favour of "Bharat Coking Coal Limited" Payable at Dhanbad.
