The date of opening of the 2<sup>nd</sup> Envelop (Part- II) of the tenders shall be communicated in due course after consideration of Ist envelop (Part – I ).

4. The minimum eligibility criteria for consideration for award of work of the Contract shall include the following.

4.1(a) The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar works during last 7 (seven) years ending last day of month previous to the one in which bid application are invited (i.e. eligibility period) should be either of the following :-

> Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

**Or**

> Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

**Or**

> One similar completed work costing not less than the amount equal to 80% of the estimated cost

4.1(b) Average annual financial turnover of civil works during the last 3(three) years ending 31<sup>st</sup> March of the previous financial year , should be at least 30% of the estimated cost.

4. 1. Similar work means: Rep.& Maint. Civil work .
