Availability of Bid Documents – Bid Documents comprising of this notice along with respective bill of quantities for the above may be collected from the Office of the undersigned during working hours on any working day free of cost from 20.01.2011 to 10.02.2011 upto 4.00 PM.

Last date of receipt – On 11.02.11 afternoon at 1.00 PM.

Date of opening of Discount Bid – On 11.02.11 at 3.00 PM in the office of the AM(Planning), Bastacolla Area in presence of the Bidders or his authorized representatives.

Place of submission of Discount Bid- Office of the Area Manager(Plng), Bastacolla Area, BCCL.

Validity period of Discount Bid Offers – The rates offered shall remain valid up to four months from the issue of work order.

General Instructionss for submission of Discount Bid.

1. The Contractor is required to submit his/their Discount Offer is sealed cover giving reference to his notice number and date as well clearly superscripting the cover with the name of the work.
2. The Bidder is encouraged to visit and examine the Site of Works and its surroundings and obtain all informations that may be necessary for submitting the Bid. The cost of visiting the Site shall be at the Bidder's own expenses and it shall be deemed that the bidder has visited the site/area.
3. The Bidder shall offer for the Whole Works as described in bill of quantity submitted by the bidder , however, the Employer reserves the right to allot part of the work at their discretion and no claims, whatsoever, shall be entertained in this regard.
4. The Bidders shall fill in rates and prices for all items of the works described in the bill of quantities. Corrections, if any, shall be made by crossing out, initialing ,dating and rewriting.
5. Any Bid received by the Employer after the deadline prescribed in the Discount Bid Notice due to any reason what so ever will not be accepted.

6. Information relating to the examination, clarification, evaluation and comparisons of Bids and recommendations for the award of the Contract shall not be disclosed to Bidders or any other persons not officially concerned with such process until the award to the successful Bidder has been announced. Any effort by a Bidder to influence the Employer's processing of the Bids or award decision may result in the rejection of his Bid.

7. Bids determined to be substantially responsive will be checked by the Employer for any arithmetical error. Errors will be corrected by the Employer as follows:

a) Where there is a discrepancy between the amounts in figures and in words, the amounts in words will govern; and

b) Where there is discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern.

c) Discrepancy in totaling or carry forward in the amount quoted by the Contractor shall be corrected.

8. The tendered sum so corrected and altered shall be substituted for the sum originally tendered and considered for acceptance instead of the original sum quoted by the Bidder alongwith. The amount stated in the bid will be adjusted by the employer in accordance with the above procedure for the correction of errors and, shall be considered as bidding upon the Bidder.

9. The Bidder, whose Bid, has been accepted, will be notified of the award by the Employer prior to the expiration of the Bid validity period by Cable, Telex or Fascimile confirmed by Registered Letter. The Letter (hereinafter and in the conditions of Contract called the "Letter of Acceptance") will state the sum that the Employer will pay the Contractor in consideration of execution and completion of the work by the Contractor as prescribed by the Contract (hereinafter and in the Contract called "The Contract Price"). The notification of award will constitute the formation of Contract, subject only to the furnishing of a Performance Security/Initial Security Deposit in accordance conditions of SOR-2010-2011.

10. Contractors are to employ, to the extent possible, only local project affected people and pay wages not less than the minimum wages fixed by the Laws of the Land.

11. Matter related to any dispute or difference arising out of this tender and subsequent contract awarded based on the Bid shall be subjected to the jurisdiction of the Dhanbad Court only.

12. Penal action in case of failure on the part of the Bidder-The registration of the SOR Contractor shall stand cancelled and withdrawn in case the successful Bidder fails within the specified time limit to furnish the required performance / Initial Security Deposit, sign the Agreement and the Bidder does start the work within stipulated time. Once a SOR registered Contractor is penalized on this count, he may as a special case appeal to the Director(Technical), BCCL for Re-registration for which the de-listed SOR Contractor will have to deposit Rs. 10,000/- towards re-registration fee (non-refundable) on receipt of demand from BCCL. management to deposit the same. However, re-registration of a de-listed SOR Contractor will be on the sole discretion of BCCL Management.

The Company is not under any obligation to accept the Lowest Bid and reserves the right to reject any or all Discount Bids without assigning any reasons what-so-ever and also to distribute the work and allot the work/s to more than one Bidder at its sole discretion.
