

Minutes of Pre-Bid meeting held on 25.01.11 at 11.00 AM in connection with the work of **“Hiring of HEMM for removal of OB, extraction and transportation of coal from IV(Top), IV(Bot), III(Top) and III(Bot) seams of Golukdih NC Project (Northern Sector) of GOCP/KOCP of Bastacolla Area”**

The representatives of the following intending tenderers participated in the pre-bid meeting :

The intending tenderers were informed at the outset that pre-bid meeting is only for clarifications and no change/deviation in NIT will be permitted.

The intending tenderers were informed regarding some of the new clauses introduced in the tender document. They were advised to go through these clauses in addition to all other clauses of tender document meticulously before submitting the tender so that they fulfil all the criteria of the tender.

The intending tenderers were informed that they have to submit their bid strictly in accordance to NIT in 04 (Four) sealed envelopes together sealed in one outer envelope. The four sealed envelopes as mentioned above shall consist of : (1) **Envelope for cost of tender document & undertaking** (in case tender document is downloaded from website), (2) **Envelope for Earnest Money Deposit**, (3) **Envelope for Techno-Commercial bid (Part-I)** and (4) **Envelope for Price Bid (Part-II)**. Non compliance of the system for submission of bid as per NIT will result in disqualification of bids. They were further informed that BG submitted in lieu of EMD should be only be payable/encashable at Dhanbad/Kolkata as per terms and conditions of NIT.

The intending tenderers were informed about clause no. 20 of “Additional Terms and Conditions” which has been recently introduced in the tender document wherein it is stated that the tenderer is to deploy permanent work force during the entire period of contract.

It was also informed to them that as per clause no. 3.3(c) of ‘Instructions To Bidders’ of tender document, the bidders are required to submit only an affidavit as per Annexure-F of the tender document.

Subsequently, some other points in respect of status of land regarding any encumbrances, forest clearance etc were raised by the representatives of the intending tenderers which were suitably clarified.
