- 2. The Bidder is encouraged to visit and examine the Site of works and its surroundings and obtain all information that may be necessary for submitting the bid. The cost of visiting the site shall be at the bidders own expense and it shall be deemed that the bidder has visited the site/area.
- 3. The Bidders shall offer for the whole works as described in bill of quantity submitted by the Bidder, however, the Employer reserves the right to allot part of the work at their discretion and no claims, whatsoever, shall be entertained in this regard.
- 4. The Bidder shall fill-in rates and prices for all items of the Works described in the Bill of Quantities. Corrections, if any, shall be made by crossing out, initialling, dating and rewriting.
- 5. Any Bid received by the Employer after the deadline prescribed in the discount bid notice due to any reason whatsoever will not be accepted.
- 6. Information relating to the examination, clarification, evaluation and comparison of Bids and recommendations for the award of a contract shall not be disclosed to Bidders or any other persons not officially concerned with such process until the award to the successful Bidder has been announced. - 8. The tendered sum so corrected and altered shall be submitted for the sum originally tendered and considered for acceptance instead of he original sum quoted by the bidder along with.
