Three similar completed works each costing not less than the amount equal to 40% of the estimated cost (i.e. Rs.2,35,491.00)

- "TECHNO COMMERCIAL BID" & "PRICE BID" will be opened only for those who have deposited the requisite "Earnest money"
- "TECHNO COMMERCIAL BID" will be opened at 03.30 P.M. on 10/03/2011 in the office of undersigned in presence of attending tenderers or their authorized representative.
- The "PRICE BID" of only those tenderers will be opened whose offers are found Technically Acceptable. The date & Time of opening of Price Bid will be intimated subsequently.

GUARANTEE: 06 (Six) Months from the date of commissioning.

VALIDITY: Rate offered in Part – II should be valid for 180 Days from the opening of Part – II i.e. "PRICE BID"

PENALTY: If the job is not executed within Stipulated Period as mentioned above Penalty @ 1% will be imposed for delay per week to a maximum of 10%.

TAXES: Necessary taxes & Duties will be levied as per rule.
