The Tender will be received on 02.03.2011 from 10.00AM to 1.00PM in Tender box at (1). CISF post near Koyla Bhawan gate, Koyla Nagar, BCCL, Dhanbad. (2). CISF'S office of EJ Area and (3) CISF Office of Ropaeway Area And (4) CISF's Office EWZ Area And will be opened on 04.03.2011 at 4.00 PM in the office of the ACE/EJA.

**1. ELIGIBILITY CRITERIA**

- a). The intending Tenderer must have in its name as a prime contractor experience of having successfully completed similar works during last 7(seven) years ending last day of month previous to the one in which bid applications are invited should be either of the following :- (1). Three similar completed works each costing not less than 40 % of the estimated cost. Or (2). Two similar completed works each costing not less than 50 % of the estimated cost or (3). One similar completed work costing not less than 80 % of the estimated cost. **Similar work means : Building works.**
- b). Average annual financial turnover of civil works during the last three years, ending 31<sup>st</sup>. March of the previous financial, should be at least 30 % of the estimated cost.
2. The Tender documents can be had from the office of the undersigned during the period mentioned above on deposition of requisite cost of Tenser paper in form of cash bank draft of any nationalized bank/scheduled commercial bank approved by Reserve bank of India in favour of "Bharat coking coal limited" payable at Dhanbad.
