Tender will be received up to 3:00 PM on 25.05.2010 and will be opened at 4:00 PM.

**Eligibility Criteria :**

- The intending tenderer must have its as a prime contractor experience of having successfully completed similar nature of job during last 7(seven) years ending last day or months previous to the one in which bid application ere invited (i.e. eligibility period) should be either of following:-
  - Three similar completed works each costing not less the amount equal to 40% of the estimated cost.  
OR
  - Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.  
OR
  - One similar completed works each costing not less than the amount equal to 80% of the estimated cost.
  - Similar works: Repairing and construction of WBM road.
- Average annual financial turn over of civil work during the last 3 (three) years ending 31<sup>st</sup> March of the previous financial year should be at least 30% of the estimated cost.
- Intending tenders should submitted permanent account number issued from IT department. Also the tenderer must be registered with the appropriate State Govt. Authority in accordance with sale tax act.
- The tender documents can be received from office of the ACE WJA Area BCCL on deposition of requisite cost of tender paper in form of cash with cashier, WJA Moonidih.
