The technical Bid is to be incorporated with valid electrical contractors license, Supervisory License for 11KV Lines, VAT Registration, PAN Card, Service Tax Registration, Past Experiences, Deed of partnership/proprietorship, Letter of credit Card from bank, list of tools and plants, Company's Profile and Earnest Money.

Technical Parameters:- The intending bidders must have in their name and having successfully completed the similar nature of work in Government/Public sector undertaking In last 7 years ending with the last day of the month previous to the one in which bid application are invited, should be as following:-

- (i) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost Or
- (ii) "Two" similar completed works each costing not less than the amount equal to 50% of the estimated cost. Or
- (iii) One similar completed works each costing not less than the amount equal to 80% of the estimated cost.

Similar Nature of work Means:- Commissioning /Installation of 440 O/H Line works.
