1. The intending tenderers must have in its name, experience of having successfully completed similar work during last 7 years ending last day of month previous to the one in which bid application are invited should be either of the following: -

a) Three similar completed works each costing not less than the amount equal to 40% of the estimated value.

OR

b) Two similar completed works each costing not less than the amount equal to 50% of the estimated value.

2. Average annual financial turn over during last three year ending 31st March of the previous financial year should be at least 30% of the estimated cost.

1.0 The work proposed is envisaged and measured against security purpose , detection of explosives and stolen property and tracking of criminals and guarding of company properties by deployment of dog squads with handlers including all complete jobs. The dog will be deployed as and when required by BCCL for the purpose.

2.0 The work will be executed directly under the supervision of CISF authority and payment of the bill will be accordingly processed through CISF authority who will certify its performance during the month. for clearance of payment from BCCL.

TERMS & CONDITIONS

1 The Contractor shall make available dogs with Handlers & supervisor round the clock for use on regular basis and any time as and when required by Bharat Coking Coal Limited.

2 The Contractor shall ensure regular deployment of dogs, handler & supervisor. In case of non-deployment of Dog squads the proportionate amount shall be deducted from the bill of the agency. For any non-deployment of dogs due to deficiency/sickness beyond 07 days, an additional penalty @ 1.5 times of the proportionate amount payable for the period of absence beyond 07 days shall be levied.

3 The dogs should be from high pedigree background like German Shepherd, Doberman, Boxer, Rottwiller and Labrador Retriever.

4. The Contractor shall change the dog at the site in case of illness of the dog or complaint against it.
