- 7. Bids determined to be substantially responsive will be checked by the Employer for any arithmetical errors. Errors will be corrected by the Employer as follows:
 - a. where there is a discrepancy between the amounts in figures and in words, the amounts in words will govern; and
 - b. where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern.
 - c. discrepancy is totaling or carry forward in the amount quoted by the contractor shall be corrected.
