(7) Strengthening of Heel with bore up to thickness 5 inch by welding with 20 mm plate. (8) Rebuilding and strengthening of Dipper Body lip with tooth point lock portion and fitting of tooth point. (9) Welding / Rebuilding of bushing bore and new bush fitting. (10) Door Assy crack portion welding.
- (11) Strengthening of Door Assy both side (front & rear) with 20 mm thick plate. (12) Fabrication & strengthening of Latch Bar and Latch lever with guide area (Door Assy rear portion).
