**ELIGIBILITY CRITERIA**

2. The intending tenderer must have in its name experience of having successfully completed similar works during last 7 (seven) years ending last day of the month previous to the one in which bid applications are invited (i.e. eligibility period) should be either of the following:

\*Three similar completed work each costing not less than amount equal to 40% of the estimated cost

OR

\*Two similar completed work each costing not less than amount equal to 50% of the estimated cost

OR

\*One similar completed work costing not less than amount equal to 80% of the estimated cost.

3. Similar work means : Transportation of materials/ belt conveyors in u/g mine.

4. Tenderers should also give the break up of activities along with the time schedule for completion of the job to be completed in two months.

5. Tender documents with full details & specification can be have from the office of the undersigned from 03.08.2010 to 07.08.2010 and sealed tender will be received upto 4.00PM on 09.08.2010. The sealed tender of Technical bids will be opened on 09.08.2010 at 4.30 PM. before the tenderer or their authorized representatives. In case of tender documents down loaded from BCCL site cost of tender paper should be deposited in the form of Demand Draft in favour of BCCL.

6. Authority reserves the right to reject any or all the tenders without assigning any reason whatsoever and split up the work between two or more Tenderers .

7.Earnest money should be deposited in cash with the chief cashier ,W.J.Area,Moonidih or in shape demand Draft in favour of BCCL, Cash CreditA/C payable at any Nationalised Bank at Dhanbad.
