2. Earnest Money/Bid Security :

Rs.42,47,700/- (Rupees Forty Two Lakhs Forty Seven Thousand Seven Hundred) only as Earnest money/Bid security is to be deposited in the form of irrevocable Bank Guarantee (from any Scheduled Bank payable at its branches at Dhanbad / Kolkata) with validity 28 (Twenty eight) days beyond the validity of the Bid in the format given in the Bid Document. 3. Eligibility Criteria (to qualify for the award of the contract) :

- a) The bidder must have in its name experience of having successfully executed works of similar nature (such as Transportation / Removal of Coal/ Overburden/ Shale/ Extraneous materials/ Sand/ etc.) valuing 65% of the annualized value of the work or the estimated value of work whichever is less, put to tender in any year during last 07(seven) years ending last day of month previous to the one in which bid application are invited.

For substantiating past experience, the bidder should submit the work orders, certificate of actual works already executed and TDS certificates.

- b) The bidder must produce evidence of adequacy of a minimum working capital (either 20% of the annualized value of the work or the estimated value of the work whichever is less) for this contract. In case of obtaining credit, the certificate from scheduled bank should be produced.
- c) The bidder is required to give an undertaking in the form of an Affidavit in the prescribed format to deploy matching equipments/tippers/pay loaders etc either owned or hired. (Format placed in Annexure F of Tender Document)
- d) **Sub Contractor's experience** and resources will not be taken into account in determining the bidders' compliance with qualifying criteria.
