## Amendment in original tender document

Further to tender notice no BCCL/TENDER/GM(CMC)/F-SILO/2009/1666. dated 06.11.2009, corrigendum notice no1765 dated 25.11.2009, Extension notice vide ref no BCCL/TENDER/GM(CMC)/F-SILO/2010/556 dated 05.04.2010, Amendment vide ref. no. BCCL / TENDER/GM(CMC)/F-SILO/2010/575 dated 06.04.10 & BCCL / TENDER/GM(CMC)/F-SILO/2010/586 dated 08.04.10 for the work of "Planning. Design, Engineering, Construction, Fabrication, Supply, Erection, Trial-run, Commissioning and Testing of Coal Handling Plant 5.0 Mtpa capacity with loading arrangement through Silo consisting of all Civil, Structural, Electrical and Mechanical Works and all other accessories and facilities required to make it complete in all respects, along with approach road on turnkey basis," following additional amendments are made in the tender document which are as follows:

## 1. Additional Clause 2.5 in Section -2 (Instruction to Bidders):

In case the bidder is a consortium of two or more parties, as members, either of the members or combination of members together should meet the above eligibility criteria. Members of the consortium shall enter into a Memorandum of Understanding (MOU) for the purpose of this project, which shall be submitted by the bidder along with tender. If the successful bidder is a Joint Venture or a Consortium, then all partners of the Joint Venture or all members of the consortium shall be required to be signatories to the contract agreement and shall jointly and severally be responsible and liable for execution of the project. For the purpose of submission of tender, consent letters from consortium members need to be submitted.

#### 2. Additional Clause 2.6 in Section -2 (Instruction to Bidders):

**Consortium**: Two or more companies / parties, as responded in the tender for this work, may jointly undertake contract. Each member will be jointly and severally responsible for completing the task as per the contract.

The consortium shall comply with the following requirements:

Authorization in favour of leader of the Consortium shall be evidenced by submitting with the bid a Power of Attorney signed by legally authorised signatories of each Consortium member.

**Note:** Qualification information as specified in tender document shall also be applicable for members of Consortium.

3. Clause 4.1 of Section -2 (Instruction to Bidders) shall be read as follows:

Each Bidder shall submit only one Bid, either individually, or as a partner in a partnership firm or a partner in a joint venture or a public limited firm or a member of a Consortium. A Bidder who submits or participates in more than one Bid (other than as a subcontractor or in cases of alternatives that have been permitted or requested) will cause all the proposals with the Bidder's participation to be disqualified.
