COST OF TENDER DOCUMENTS: Cost of Tender documents shall be payable either in cash deposited to Area Finance Manager, Lodna Area, BCCL OR Demand Draft of any Nationalized Bank in favour of "BHARAT COKING COAL LIMITED" payable at "DHANBAD".

LAST DATE OF RECEIPT & OPENING OF TENDER: The sealed offer will be received in the office of the undersigned up to 01.00 P.M. of 21/08/2010 and will be opened on the same date 21/08/2010 at 01.30 P.M. by the Tender Committee, in presence of tenderers or their authorized representative.
