- 1) **Sealed Quotations should be submitted in the tender box of purchase department, Sijua Area-V or should reach by post to Area Manager (MM) ,Sijua Area –V ,BCCL, P.O. SIJUA. Dhanbad on or before -10.09.2010- by 1.00 P.M.**
- 2) **Offers to be submitted in two bids(Techno Commercial & Price bids) in separately sealed envelopes. The Techno Commercial bid must contain the following**
 - A) **Technical specification for “CEMENT CAPSULE” should contain the following information & documents.**
 - i) **a) Anchorage load - in ½ hrs. 3 MT minimum . in 2hrs - 5MT minimum in 28days 8MT minimum.**
 - b) **Product (Cement Capsule) should be of standard composition and properties as per DGMS/S&T/Tech.Cir (Approval No 2 DHANBAD 18TH June 2009). & DGMS.Tech.Cir. Approval (No – 4) of 15th June 2010.**
 - c) **Cement Capsules should be supplied in water proof packets .**
 - d) **Test Report as per DGMS/S&T/Tech.Cir (Approval)No 2 Dhanbad 18th June 2009.**
 - ii) **Product should be chloride free and thixotropic in nature, Test Report to that effect must be submitted with Part –I.**
 - iii) **Confirmation regarding product that it should not have itching effect. Confirmation to the effect that product must be packed in bags. Date of manufacture Batch No . & Dt.of Expiry and manufacturer name must be printed on each & every bag. Tagging in bags is not allowed .**
 - iv) **Confirmation to the effect that in case the performance is not found satisfactory the materials will not be returned to the supplier and it will be destroyed at our site with the presence or information to the supplier. The supplier will not have any claim of payment for the said supply.**
 - v) **All the above eligibility criteria must be fulfilled for qualifying in Part – I. Part – II (price Bid) of those Firm will be opened who will qualify in Part – I (Tech.Bid) only.**
