- 3) The tenders should contain in two parts i.e. Part-I (Technical Bid) and Part-II (Price Bid). The tenders are to be sealed in different two envelop i.e. (1) Part-I and (2) Part-II and these two envelops are also to be sealed in 3<sup>rd</sup> envelop. The first part that is technical bid enclose the proof of earnest money.

- 10) The Load cell should be compression type, water proof and out put Volt 2-3 Mille volt and of reputed make. Test certificate should be submitted along with load cell.
- 11) Weighing indicator (Digitizer) must be micro processor based J.B. surge protected in built. Software window based with Lan communication facilities.
- 12) The job must be completed within 10 (Ten) days.
- 13) The tenderer/contractor will have to bear guarantee for 12 (Twelve) months from the date of installation for Load cell and Digitizer.
- 14) For any delay, the penalty will be imposed @ 0.5% per week or part there of, limited to 5%.
- 15) Contractor shall have a valid repairing license for Road Weigh Bridge issued by weights and Measure Deptt. Of Jharkhand/West Bengal as the case may be and copy will be provided to Area.
- 16) Contractor shall provide full medical treatment to his staff and labour in case of any accident on duty. B.C.C.L. shall have no responsibility whatsoever towards staff/labour deployment by contractor.
