- 8. Tenders must be submitted in one sealed envelop containing separately two sealed envelopes. The first envelope should contained Technical and Commercial terms. The 2nd Envelop should contain price bid only. It may be noted that on the due date of tender opening only technical tender will be opened. Only such price will be opened for Consideration which are primarily found to be Technically fit for acceptance.
