3. The prices quoted must be exclusive of Sales Tax / VAT / Excise Duty forwarding and Packing Charges etc. The rate at which these taxes are applicable must be separately mentioned. If no mention is made of these Taxes it will be presumed that prices quoted are inclusive of these tax. No charge will be entertained later on.

6. It should be indicated whether the rates quoted are as per D G S & D and BCCL Rate contract if in existence or open market trade rate. If the rates are as per DGS&D or BCCL Rate Contract a copy of the same along with tender should be furnished.

7. Only type written offer must be submitted.
8. Tenders must be submitted in one sealed envelop containing separately two sealed envelopes. The first envelope should contained Technical and Commercial terms. The 2<sup>nd</sup> Envelop should contain price bid only. It may be noted that on the due date of tender opening only technical tender will be opened. Only such price will be opened for Consideration which are primarily found to be Technically fit for acceptance.
