1. In place of existing stipulation, the clause no. 17.1 & 21.1 of 'Instructions to Bidders' of Tender Document may be read as given below :

**Clause No.17.1** of 'Instructions to Bidders' of Tender Document:

"Sealed Tenders/bids have to be submitted by the tenderers in four envelopes duly sealed in, in one outer envelope indicating full postal address and telephone nos. of the tenderers. Four Envelopes as mentioned above will consist of : (1) **Envelope for cost of tender document & undertaking** (in case tender document is downloaded from website), (2) **Envelope for Earnest Money Deposit**, (3) **Envelope for Techno commercial bid (Part-I)** and (4) **Envelope for Price Bid (Part-II)**. Outer sealed envelope will be marked as "Bidding Documents for....."

**Clause No.21.1** of 'Instructions to Bidders' of Tender Document:

"After opening of outer envelope of the bids, in the presence of the bidder's or their representatives who choose to attend at the time and in the place specified in Clause 18, the Employer will first open (1) envelope containing cost of tender document & undertaking (in case tender document is downloaded from website) and (2) envelope containing Earnest Money. If these are found to be in order as per requirement of NIT, then only the techno-commercial bid (Part-I) of the tender including modifications made pursuant to Clause 20, shall be opened. Otherwise the tender will be rejected without opening Part-I. In the event of the specified date of Bid opening being declared a holiday for the Employer, the Bids will be opened at the appointed time and location on the next working day"

2. The sale period, date of receipt and opening of tender for the above mentioned work are hereby extended as under :

Date of Receipt of tender : **On 23.09.10 up to 3.30 PM**

Date of opening of Tender : **On 24.09.10 at 4.00 PM**
