Rates must be quoted on F.O.R. destination basis (Ghanoodih Regional Store, Bastacolla) In case of Ex - godown or Ex - despatching Station deliveries, Rates of freight upto destination must also be quoted separately. The offers should strictly be submitted as per instruction contained under Sl. No. 1 to 21. of Terms and Conditions given below. Offer which deviates from our Techno & Commercial Terms may be ignored.

2. Warranty of Materials for atleast 5 (five) Years.
3. Detailed Specification of Materials must be indicated in the Quotation.
4. The Rate must not under any Circumstances be altered. Quotation with Overwriting may be Ignored.
5. The prices quoted must be exclusive of Sales Tax / VAT / Excise Duty forwarding and Packing Charges etc. The rate at which these taxes are applicable must be separately mentioned.
